# PRESIDENT'S CORNER

# "RECAPPING A PRESIDENTIAL YEAR"

It's been quite a journey for me from volunteering as Chair of the Fish Culture Committee back in 1999 to being elected into the President-Elect. President, and soon to be Past-President series of the Oregon Chapter of the American Fisheries Society. Being involved as an officer, especially as President, has also helped me recognize that we make contributions beyond the State of Oregon, as part of a larger organization, involving the Western Division (www.wdafs.org). For example, the Oregon Chapter participated in the Western Division review of the Federal Columbia River Power System Biological Opinion. This AFS review independently confirmed the recent ruling in U.S. District Court that the 2004 plan was insufficient for protection and recovery of listed salmon and steelhead in the Columbia River. Another Western Division activity to pay attention to includes the 2005 election of candidates, including the run by our very own Dave Ward for Secretary-Treasurer. Bob Hughes, another Oregon AFS member, is the current Vice-President of the Western Division, moving on to President in the coming year. And come this September, Barry McPherson, as President of ORAFS. will be representing the Oregon Chapter at the Western Division business meeting in Anchorage, Alaska. Congratulations to Dave and Bob, and I look forward to hearing from Barry on his adventure to Alaska.

One of the reasons I was nominated to run for President of Oregon AFS had to do with my involvement and experience with the science and management of salmon and steelhead hatcheries. This issue was "hot" back in 1999-2001, which led to the development of the ORAFS white paper "Managing Wild

and Hatchery Fish in Oregon" (http://www.orafs.org/pdfdocs/ wildhatch.pdf). This paper is an example of Oregon AFS members working together, each having different expertise in science, management, and communications, representing diverse and opposing views, coming together to articulate an ORAFS position. This white paper was effectively used by ORAFS representatives in communications with the state legislature and their staff. I would like to think that ORAFS support also influenced the development and funding of the new Hatchery Research Center (see www.dfw.state.or.us). I encourage ORAFS to continue to build positive relationships and open dialog with hatchery management profession-

A recent news headline that caught my attention was the proposal by the Federal Government for expansion of off-shore coastal development of Sea Ranches. While I am sure ORAFS members have different views on this topic, I am just as sure that an important item needs to be injected into this proposal, and that item is including an objective scientific review and environmental assessment of this proposal, as well as developing monitoring and evaluation guidelines, if implemented.

Another ORAFS position paper (also found on our web site) pertinent to this issue, covers the topic of "Marine Reserves" (http://www.orafs.org/pdfdocs/marinerespos03.pdf). As stated in the position paper, an Executive Order was issued in 2000 by then President Clinton for federal agencies to work together to "develop a scientifically based, comprehensive national system of marine protected areas representing diverse U.S. marine ecosystems, and

the Nation's natural and cultural resources." In Oregon, the Ocean Policy Advisory Council recommended to former Governor Kitzhaber that Oregon establish a limited system of marine reserves in the Oregon territorial sea in order to test their effectiveness. Two phrases that are important to emphasize from the two previous sentences are: "scientifically based" and "test their Continued on page 2

effectiveness". I would hope the present State and Federal administrations will consider the same emphasis in science when considering ocean sea ranches, as well as consider establishment of scientifically-defensible Marine Reserves.

All of the issues mentioned above are part of External activities of the Chapter. External reviews completed during my term included comments to State of Oregon forest practices act, NOAA Fisheries proposed critical habitat designations, and their proposed hatchery listing policy. These "letters from the President" are posted on our web site. To get involved I encourage you to be a part of the development of Information Sharing Networks (ISN) and/or our Chapter's External Committees. Many thanks to Tom Friesen and committee chairs in leading the charge, and to Don Ratliff and Hiram Li in helping foster development of ISNs.

Now on to Internal business. On May 5-6, Oregon AFS officers met in Seaside to discuss past and future business. Thank you to those attending, including: Barry McPherson, Dave Ward, Mike Matylewich, Tom Friesen, Peter Ober, Neil Ward, Mike Reed, Ian Reid, and Loretta Brenner. ahead by almost \$10,000 last year, largely because of a very successful annual meeting. This money will be invested for future endeavors by the Chapter (thank you to Mike Matylewich for leading the adhoc investment committee). While not yet approved, current annual budget plans for Fiscal Year 2006 are for zero deficit spending. One of the larger cost savings is with electronic distribution of the newsletter. I am planning on sending out a survey to members prior to the annual meeting to gauge membership satisfaction with this newly developed distribution method. Other noteworthy work plan and budget items that we are planning are: continue aquatic education for teachers, support student sub-unit activities, promote three or more student scholarships and three AFS certification scholarships, maintain an annual reserve to promote development of fishery and aquatic science professionals, continue our contract for administrative assistance (thank you to Laura Tesler for working with Loretta Brenner), and of course, conduct our Annual Meeting in March 2006 in Sunriver (thanks to Molly Webb, and our incoming Internal Director Neil Ward, and incoming President-Elect Mike Reed).

In this issue is a call for 2006-2007 Oregon Chapter AFS officer nominations (see page 7) These are leadership positions of responsibility that will help the profession and organization continue to grow in the direction you would like. All levels of experience are desired, from student to senior scientist, from seasonal technician to program manager; please consider who you would like to see in officer positions for your Chapter. Planning is underway for the 2006
Oregon Chapter AFS Annual Meeting to be held March 1-3, at Sunriver Resort, Sunriver, Oregon. The theme of the meeting "Addressing Fisheries Issues in the 21st Century" will be the focus of our plenary sessions and the meeting will include our usual array of outstanding technical sessions, posters, contributed papers and social events. Deadline for Submission of Abstracts is November 28, 2005 (see pages 4-5 for Abstract Guidelines).

We are going to follow the same format for plenary speakers that we followed at the 2005 annual meeting by starting each of the three days with a speaker. We have some ideas for some dynamic plenary speakers who fit the meeting's theme, but are still open to suggestions.

The theme of addressing fisheries issues in the 21st century is intended to get us thinking about the challenges that we are not only facing today but will face in the future. Are we making headway on the challenges currently facing fish and their habitats? How do we prepare for the challenges that face us in the future? How can we as a Fisheries Society, as well as individuals representing diverse public and private organizations, prepare for these challenges?

- Salmon Ecology

- Education

Topics for other technical sessions are also welcome, especially those related to the theme. As in the past, we will make room for sessions dedicated to contributed papers and a poster session combined with a Chapter social We are looking for conveners and speakers for these technical sessions.

We want to encourage participation from students including presenting papers, displaying posters, meeting with mentors, etc. We have some great ideas for workshops that will be offered at the meeting but are also open to suggestions and interested organizers. Abstract Submission Deadline: November 28, 2005 (5:00 P.M.)
Abstracts must be submitted via email as an attached Word or WordPerfect file.

We ask that both paper and poster presenters register for either the full or one-day annual meeting option. Registration information will be available in September 2005 in the fall newsletter and on the Oregon Chapter website.

# Instructions for Submitting Abstracts for Paper or Poster Presentations

### INCLUDE THIS INFORMATION WHEN SUBMITTING YOUR ABSTRACT:

- 1) PRESENTER INFORMATION (Place at the top of your paper or poster abstract):

  Name, employer or affiliation, mailing address, city, state, zip code, phone, and email address.
- 2) Indicate if paper or poster presenter is:
  - a) an AFS member and indicate your chapter(s) of membership, e.g. Oregon Chapter.
  - b) planning to use presentation device other than a computer projector for paper presentation. PowerPoint or other computer-compatible presentations are required (with few exceptions); please contact the Annual Meeting Program Chair if you want to use slide projectors or other presentation devices.
  - c) a student; if you are a student, please indicate if you want to be included in the best student paper or poster competition; all students are eligible for these competitions. **Presented work needs to have been done while a student, not as an employed professional who is currently enrolled as a student.** Students who fail to indicate their desire to be included in the best paper or poster judging competition by the abstract deadline (November 28, 2005) will not be considered for judging. Student winners receive an award and acknowledgement at the 2006 Annual Meeting, and recognition in the *Piscatorial Press* and *Fisheries* publications!

(Papers not designated for a session will be included in the contributed paper sessions or fit into other sessions). Include 1 space between line 2 and abstract title

ABSTRACT TITLE: Use upper and lower case, and bold font. Include 1 space between title and list of authors;

**LIST OF AUTHORS:** Use upper and lower case; first name or initials followed by last name; author name followed by a superscript number to reference author's contact information (the same number should be applied to each author having the same contact information); each author then separated by a comma (see sample abstracts on page 6);

**PRESENTING AUTHOR(S):** Use an \* to indicate the presenting author(s). No space between authors and contact information.

**AUTHOR CONTACT INFORMATION:** Use upper and lower case. Using **superscript numbers** to reference authors, list employer or affiliation, mailing address, city, state, and zip code. Include phone and email only for the presenting author(s). Include 1 space between contact information and the body of abstract.

**ABSTRACT (250 words or fewer):** Use sentence case (the combination of upper and lower case used in a typical sentence).

ABSTRACT DEADLINE: NOVEMBER 28, 2005, 5:00 p.m. (submit as an email attachment, see information below)



- May be a single contribution of major national or regional importance or a substantial, sustained contribution to fisheries science or the Society.
- Shows evidence of cooperative work that produced results greater than would likely be achieved by individuals working independently.
- Demonstrates results that significantly promote sound fisheries and resource management practices.
- Each individual identified as "part of the team" must have made substantial contribution toward the outcomes touted as the main efforts of the team.
- At least one team member must be a member of the AFS Parent Society.
- May or may not be presented each year.

# **Fishery Worker of the Year**

- Substantial lifetime contribution to fisheries or single contribution of major national or regional importance.
- Active participation in other conservation, professional or social organizations that promote sound fisheries and resource management practices.
- Usually presented to one person per year, but multiple awards can be presented.
- Must be an AFS Parent Society member.
- May or may not be presented each year.

# **Award of Merit**

- Nominees may be an individual, organization, or a group.
- Major contribution, above and beyond normal job requirements, to fisheries or the society over one or more years.
- Evidence of creativity, cooperation and results.
- May be a member or non-member of the AFS Parent Society.

# Bill Wingfield Memorial Award in Fish Culture

- For major or sustained accomplishments in fish culture.
- May be presented to an individual or group of people working together.
- Individual must be a member or at least one member of the group must be an AFS Parent Society member.

# **Broken Oar Award**

- Most embarrassing field incident.
- Nominee may be a member or non-member of the AFS Parent Society.

Everyone's favorite and just for fun; the Broken Oar Award is presented for "an outstanding display of field technique and coordination." No doubt you already have some nominees in mind from this year's "memorable" field season

# Oregon Chapter AFS Undergraduate and Graduate Student 2006 Scholarship Application Guidelines

The Oregon Chapter of the American Fisheries Society is proud to announce a competition for three student scholarships (undergraduate, Master's, and Doctoral student categories). Scholarships will be formally awarded at the 2006 Oregon Chapter annual meeting at Sunriver Resort, Oregon. The goal of these scholarships is to further the objectives of AFS by rewarding and promoting the education and development of future fisheries professionals. The award will consist of a check for \$1,500, one year of student membership in AFS (may be a renewal), an award certificate, recognition at the 2006 annual meeting and in the Fisheries journal and the Piscatorial Press, and group lodging and refunded registration at the 2006 Oregon Chapter AFS annual meeting March 1-3, 2006.

# **APPLICANT REQUIREMENTS**

- 1. Applicant must be enrolled in, or have been accepted for, admission into a degree program within the state of Oregon.
- 2. Applicant's major field of study must be relevant to fisheries science.
- Applicant must be a current member of AFS, but may join AFS at the time of scholarship application (see National AFS website (www.fisheries.org/ html/forms.shtml) and be sure to sign up for the Oregon Chapter membership at \$2/year.
- 4. Applicant must not have been previously awarded the Oregon Chapter AFS scholarship.

### APPLICATION PROCEDURE

Each applicant must submit the following:

- A short, 3-page essay (maximum 1,400 words, single spaced) describing how your academic and professional development has and/or will contribute to the AFS objectives of:
  - •advancing the conservation, development, and appropriate use of fisheries resources;
  - •promoting the development and advancement of all branches of fisheries science;

•gathering and disseminating scientific and technical information about fisheries; and

•encouraging the teaching of fisheries science and practice in colleges and universities.

You are encouraged to include undergraduate and graduate experience and/or research, along with volunteer and work experience, to demonstrate the relevance of your professional development to the objectives of AFS. Essays may also describe any grants, honors, or awards you have earned; or the influence of a class project and how you think your future contributions to fisheries science issues will promote the objectives of AFS. Essays will be judged based on the ability to communicate your ideas in writing and how well your goals further the objectives of AFS.

Include your name, address, phone number, email address, school and department of enrollment, major, year in college, degree pursuing, anticipated graduation date, and AFS membership number or proof of membership application.

- Copies of transcripts from all colleges or universities attended to date (internet-generated transcripts or photocopies of official transcripts will be accepted).
- Two letters of recommendation from mentors or other professionals, one of whom must be an AFS member. The letters should address the potential of the applicant to be a productive member of AFS and to contribute to fisheries science in the future.

# NO CLAMS AT EXCOM RETREAT

The Executive Committee held its annual retreat on May 5-6, 2005 in Seaside to review the past year and to identify and discuss priorities for the upcoming year. Seaside was selected in part to provide an opportunity for ExCom members to hunt the elusive and dangerous razor clam during free time; however, razor clamming was closed just days before the meeting (see, they are dangerous). Fortunately, our past year was much more successful, and prospects for the upcoming year look splendid as well.

As usual, the retreat agenda was packed, and required discussion well into the night of May 5. Our first order of business was to welcome new ExCom members who will be taking office in September: Mike Reed (President-Elect), Neil Ward (Internal Director), and Ian Reid (Secretary-Treasurer). Incoming Internal Director Karen Wegner was not able to attend.

We discussed the 2005 annual meeting in Corvallis, which was a huge success, and with over 550 attendees we set a new attendance record. The meeting generated more revenue than projected. The change in the plenary sessions to one talk starting each day drew positive comments. Comments on lodging expenses were less favorable, but this is often the

case. We also need to consider improvements to the Student-Mentor Social. As for post-banquet festivities, it seems that folks either loved or hated karaoke, but we had more people stay and have a good time than in recent years. Karaoke will be back!

We also made considerable progress on preliminary planning for the 2006 meeting, which will be held in Sunriver. The theme will center on emerging fisheries issues in the 21st century. ExCom recognized that diversity of meeting participants is important, and that we should appeal to a variety of geographic areas and species interests (including both freshwater and marine), and to fish culture specialists. With this in mind, we discussed potential plenary speakers, technical sessions, and workshops, and gave Program Chair Mike Reed plenty of ideas to pursue.

We also discussed future meeting sites. We have received interest from Corvallis and Ashland for the 2007 meeting, which, following recent tradition of alternating between sides of the Cascades will be in western Oregon. Eugene is another potential location. Ashland does not have adequate facilities for our group, so ExCom directed Neil Ward to get bids from both Corvallis and Eugene. Because of the overwhelming success of the 2005 meeting, Corvallis should be considered the early front-runner; however, some potential issues include parking, hotel rates and access to food. Neil will have his hands full with arrangements.

Neil will be even busier because ExCom agreed to host the 2008 Western Division meeting in conjunction with our annual Chapter meeting. The 2008 meeting will be in Portland because of the expected number of attendees (a temporary change to geographic tradition). The meeting will most likely be in spring rather than our usual time of late winter.

Due mostly to the better than expected revenue from the 2005 annual meeting, President Doug Olson will enjoy quite a bit of flexibility when preparing the next annual budget, which covers the period from May 1, 2005 through April 30, 2006. ExCom reviewed the projected and actual budgets for the past year, and discussed general priorities for expenditures in the upcoming year. Secretary-Treasurer Mike Matylewich distributed a draft investment strategy, and ExCom decided to form an ad-hoc Investment Committee consisting of the Past President, President, and Secretary-Treasurer (chair). The committee will report back to ExCom with specific recommendations on investments by September 1.

As for external committees, ExCom agreed that the Aquatic Habitat Committee will be changed to the Freshwater Habitat Committee and marine habitat will be deleted from the committee's responsibilities. A Marine Habitat and Ecology Committee will be created. Steve Parker has volunteered to create a work plan for the new committee. In addition to formal committees, ExCom discussed and was pleased with the early interest in the Information Sharing Networks. A follow-up survey will be done with the ISN leads to evaluate continued interest and participation. ISN coordination will be added to the External Director duties.

As usual, the Executive Committee has a full plate for the coming year. We are confident that the dedicated members of ExCom and our active chapter membership will rise to the challenge.
