The Oregon Chapter of the American Fisheries Society (ORAFS) is proud to announce the opportunity to apply for education materials and participation grants for up to \$1,000 each. These grants are intended for educators that teach fisheries or aquatic related sciences to grade levels k-12. Funds can be used for any education related materials or participation activities having to do with fisheries biology and aquatic related sciences; projects will be evaluated on how well they meet the below education goals. Funds can be used for durable gear (waders, nets, scientific instruments, dissecting scope/microscopes, etc.), educational signage, restoration supplies, curriculum development, bus services for fields trips, or other teaching needs.

Consistent with the National Chapter's guide to fisheries education for grades k-12, applications will be evaluated based on how well each meets the following criteria:

Goal 1. Help youth acquire a basic awareness and understanding of the total ecosystem in which fishes live; the commercial, sport, and subsistence fisheries supported by that ecosystem; the issues involved in managing these fisheries; and the effects people can and do have on the resource.

Goal 2. Help youth acquire positive attitudes and values toward fishes, fishing, fisheries, and the aquatic ecosystem in general, ensuring their protection, rehabilitation, and responsible management.

Goal 3. Help youth acquire the social and technical skills to make decisions and solve problems associated with the management of fisheries and the motivation to personally act on those problems. Provide youth with opportunities for personal action and evaluation of those actions.

To apply:

Please submit a brief description of your experience and programs you intend to or are currently teaching to grades k-12, how these programs fit with any of the goals above, how your proposal will meet district or national educational standards, and a brief itemization of what the funds will be spent on. Please send applications to Karen Hans at fishheads@peak.org by the grant deadline.

Strong preference will be given to applicants that involve field experience (outside the classroom), have collaborative partners, plan for implementation including administrative support, clearly incorporate Next Generation Science Standards into their project, include match funding or in-kind support, contribute towards the purchasing of gear or other durable goods, and have potential to benefit multiple students. While out of state applications will be considered, priority will be given to projects in Oregon.

OREGON CHAPTER AMERICAN FISHERIES SOCIETY **NATIVE FISH COMMITTEE** 2023 NONGAME NATIVE FISH WORKSHOP FEATURING THE GOOSE LAKE ENDEMIC FISHES **WORKSHOP SUMMARY**

On September 12-13, 25 fisheries biologists gathered in Lakeview, Oregon for the ninth annual Nongame Native Fish Workshop presented by the Native Fish Committee of the Oregon Chapter American Fisheries Society. Each year, the committee hosts a workshop featuring nongame native fish species within the State of Oregon. This year, the workshop featured the endemic fish species of Goose Lake, including the Goose Lake Tui chub, sucker, and lamprey.


This workshop was the highest attended workshop yet, with 25 participants from state and federal agencies, universities, and organizations. It started at noon on September 12 and ended at noon September 13. The first half day featured presentations in a conference room in the



Fremont-Winema National Forest Headquarters. Forest Staff Officer and previous Native Fish Conservationist of the Year Award recipient Jimmy Leal introduced the workshop participants to the Goose Lake area and resources. ODFW Assistant District Fish Bio Justin Miles provided an overview of the fisheries resources in the Goose Lake Basin. OSU Masters student Aleah Dew described community dynamics of the native and nonnative fish in the basin. Although OSU Masters student Jacob Dickey couldn't attend, we saw a video of him describing his production of a Goose Lake lamprey larvae distribution map and collaboration with UC Davis. Stewart Reid from Western Fishes pre- by the Fremont-Winema National Forest. sented a biogeographic perspective of Goose Lake fishes



relative to neighboring basins. ODFW Fish Conservation and Permitting Specialist Michele Weaver presented the freshwater mussels of the Goose Lake area. Troy Brandt from River Design Group described geologic context, aquatic endemics, conservation strategies, and restoration in the area. The presentations concluded with Brandi Nei-



der from the Goose Lake Umbrella Watershed Council introducing the group to human dimensions in the Goose Lake area. Later that evening, the Oregon Chapter provided dinner and campfire refreshments to the workshop participants. Most camped that evening at Drews Creek Campground, administratively reserved for the workshop




The next morning, we electrofished Hay Creek, within the Goose Lake Basin, under the leadership of Justin Miles and Aleah Dew. We collected Goose Lake Sucker, Pit Roach, Speckled Dace, and a California Floater mussel, all native to the area. We also collect nonnative Fathead Minnow and Brown Bullhead. The sampling location was bi-



sected by a livestock fence, allowing us to sample reaches both impacted and undisturbed by livestock grazing. The grazed reach was adjacent to a cattle collection corral, potentially exacerbating livestock impacts. We observed a healthier riparian area shading a narrower, deeper stream with a higher density of fish in the ungrazed reach. At the end of the workshop, the collected fish provided a great opportunity for photographs and further discussions regarding their biology and habitat needs.

Conference Structure and Plenary talks:

Laurie Weitkamp will be sharing her experience working on an international effort to understand salmon ecology on the high seas in winter and Brian Erickson will share some of his work using ideas from social psychology and behavioral science in the natural resource management context.

Laurie Weitkamp

Dr. Laurie Weitkamp has been a Salmon Biologist at NO-AA Fisheries' Northwest Fisheries Science Center since 1992, where she works on salmon conservation, salmon



management, and salmon research. On the conservation side, she has been involved in the scientific basis for Pacific Salmon listings and recovery under the U.S. Endangered Species Act. She works on salmon management as a member of the Coho Technical Committee of the Pacific Salmon Commission, which implements the US-Canada Pacific Salmon Treaty. Her research focuses on the ecology of salmon (and recently lamprey) in estuarine and marine environments, specifically how physical conditions influence biological processes that are important for growth and survival. Since 2019, Laurie has been involved in an international effort to understand salmon ecology on the high seas in winter, a part of the salmon life cycle about which little is known. She helped plan and participate in the In his talk, Brian will present a model of the reasons why 2022 International Year of the Salmon Pan Pacific Winter High Seas Expedition, which involved five ships sampling 2.5 million km² of high seas salmon habitat across the North Pacific Ocean in late winter. Laurie earned her B.S.. M.S., and PhD degrees from the University of Washington.

Brian Erickson

Brian Erickson is a conservation social scientist based at Oregon State University and member of the ORAFS Human Dimensions External Committee. He is a postdoctoral scholar supervised by Dr. Megan Jones in the Human Dimensions lab in the Department of Fisheries, Wildlife, and Conservation Sciences. Brian's research focuses on applying psychology and behavioral science to conservation practice to support human wellbeing and environmental sustainability. His current projects seek to understand how to support private landowner coexistence with beavers. describe and segment fish-interested community perceptions of Oregon salmonid hatcheries, and help USGS develop training modules on the science behind successful interdisciplinary team science.

Brian's training includes a B.A. in Biology from Lewis &

Clark College, an M.S. in Teaching Secondary Science from Fordham University, an M.S. in Marine Resource Management from Oregon State University, and a Ph.D. in Fisheries (Social) Science from Oregon State University. He has a highly varied professional background with an emphasis on formal and informal education and social and ecological research.

Posters are written, self-explanatory presentations that must fit within a 4x4 ft space (provided). They should be readable from a distance of 3 ft, include your contact information, and may be enhanced by photos and handouts. They will be on display throughout the meeting and featured during our Poster Social on Wednesday evening at which the lead author is expected to be present for discussions and questions regarding their research. Posters will also be posted on a meeting app to be viewed by all attendees including those registered for live-stream viewing.

Oral Presentations will be the traditional 15-minute presentation delivered live and in-person, with allowance of 5 minutes for questions. Oral presentations will be grouped into sessions according to general topics to facilitate dialogue. **New for 2024, oral presentations will be live streamed to allow viewing by live-stream attendees.**

Moderating the session means providing a laptop computer, gathering and uploading presentations prior to the session, providing a brief introduction for each speaker, moderating questions, and most importantly keeping strictly on schedule. Moderators will also make sure that the live stream is projecting so the remote audience can view the presentations. A student volunteer may be available to assist with A-V and lights in each session.

Students: The program committee is actively looking for student research to incorporate within our technical sessions. If you would like to compete for best student paper/poster make sure to check the appropriate box when submitting your abstract.

Abstracts for ALL presentations and posters must be submitted by using the online abstract form, and we are accepting abstracts starting November 6, 2023. Before you hit submit, please be sure to:

 Develop a brief but descriptive title <130 characters, including spaces, avoiding acronyms or scientific names in the title unless the common name is not widely known.

- 2) List of authors (up to five), their affiliations, addresses, telephone numbers, and email addresses.
- 3) Type a succinct abstract of <300 words that summarizes your objectives, methods, and results. This can be cut and pasted into the abstract box of the form to reduce your online time and help avoid system crashes.
- 4) For presenters that have been invited to participate in a symposium, please list the title of your symposia or the name of the symposium organizer/moderator.
- 5) For **student presenters**, please indicate if you would like to be considered for the "best student paper" and "best student poster" awards.

All presenters will receive an email confirmation of their abstract submission and will be notified of acceptance by January 13th, 2024. The schedule of talks will be available thereafter. Please submit your abstracts as soon as possible, as time slots will be limited this year. When there are no longer any 15-minute oral presentation time slots available, the opportunity for presenters to participate in the poster session may be offered alternatively.

CELEBRATE A COLLEAGUE TODAY!



You know who these people are...the hardworking peer, the inspirational mentor, the energetic teacher, the partner from another agency, the private landowner who worked so hard to do that great habitat work, or the team who overcame great obstacles to accomplish something unique. Now is a great time to start putting your thoughts on paper so you will have plenty of time to refine your nomination before the due date of **December 31**, **2023**.

For all awards except Broken Oar, you should indicate how the nominee's efforts are above and beyond their regular job. All awards are discretionary - none are required to be given each year.

To submit a nomination, please submit a completed nomination form <u>online</u> or **via email** to Awards Chair Brian Bangs at Brian Bangs@fws.gov.

Descriptions of the criteria of each award are listed below.

Lifetime Achievement Award

For those people who go above and beyond year after year. This highly prestigious award should go to an individual who has made a substantial lifetime contribution to fisheries. Substantial lifetime contributions to the American Fisheries Society and/or Oregon Chapter are also recommended. This individual should have actively participated in other conservation, professional, or social organizations that promote sound fisheries and resource management practices. They must be a member of the AFS Parent Society as well as the Oregon Chapter. This award will be presented to a maximum of one person per year.

Fishery Worker of the Year

This is one of the Chapter's highest individual awards for fisheries professionals. Nominees must be AFS members in good standing who are responsible for substantial single or sustained accomplishments above and beyond their regular job, often spanning many years. Nominations should indicate how efforts are related to the goals of guiding and influencing sound resource practices.

Fishery Team of the Year

This award recognizes outstanding teams that merit acknowledgement for excellent work beyond an Award of Merit. The stringent award criteria are similar to the Fishery Worker of the Year, but for team efforts. This award recognizes the collaborative efforts to understand and manage fisheries resources, and that these efforts frequently cross geographic, disciplinary, and socioeconomic boundaries. At least one nominee of the team must be an AFS member in good standing. The team or group must have been re-

sponsible for substantial single or sustained accomplishments. Each member of the team nominated must have produced a substantial portion of the work. Nominations should indicate how they are related to the goals of guiding or influencing sound resource practices. To demonstrate equivalent contributions, describe substantive contributions of each member of the team.

Award of Merit

This award recognizes individuals, groups, or organizations that have made special contributions, above and beyond normal job requirements, to fisheries science, or the American Fisheries Society over one or more years. Successful nominees display evidence of creativity, cooperation, and results. Nominees do not need to be AFS members.

Bill Wingfield Memorial Award in Fish Culture

Nominees should be **individuals or groups** that have contributed significantly to advancing fish culture (including fish health) in Oregon. AFS members or non-members may be nominated.

Broken Oar Award

Everyone's favorite award, and just for fun, the Broken Oar Award is presented for "outstanding display of field technique and coordination." No doubt you already have some nominees in mind from this year's field season! AFS members or non-members may be nominated.


MEMBERSHIP UPDATE
