# MHCC STUDENT SUBUNIT UPDATE

With the end of Fall term and the start of this Winter term. the students at Mt. Hood community college are excited for the opportunities that the new year can offer. Our student subunit has been hard at work planning club events and meetings, along with handling coursework and volunteering/working at the campus hatchery. Our first-year students the opportunity to visit multiple hatcheries where we can have continued to be extremely involved in the subunit, helping decorate for club meetings and even bringing in a Christmas tree for our "Fishmas" holiday party. The annual party was a huge success, with a large turnout from both the first year and second-year students. Kate Self was also kind enough to attend and give a brief overview of the student scholarships that are available through Oregon AFS and details about the upcoming annual meeting in Bend, OR.

The first-year students have successfully completed their first term of the program and finished up their salmon spawning surveys on Beaver Creek. They were able to collect some excellent data about the stream and the salmonids that are present within it, along with adding another year of information to the program's continued monitoring of the creek. With the start of the winter term, they will begin studying more detailed biological processes of fish and learn about the internal structures commonly found in fish anatomy.

Our fish husbandry classes have introduced the students to a variety of techniques necessary to be successful in fish culture and has given the second years learn practical skills while working with different species. Some examples include spawning Coho at Bonneville Hatchery and spawning summer steelhead at Merwin Fish Hatchery. The second-year students have also finalized their project proposals and will begin collecting data for their field projects this winter term.

Some club members of the subunit were able to attend the Northwest Fish Culture Concepts meeting this year in Boise, Idaho. We all had an excellent time and enjoyed learning about what's new in fish culture. It was an excellent opportunity for the students to network and visit with professionals within the industry. Everyone is also looking forward to the upcoming annual Oregon AFS meeting this year, and we are eager to volunteer wherever we can. All of us at MHCC want to wish everyone a Happy New Year and we look forward to what this year could bring!

# PLENARY SPEAKERS

# **Laurie Weitkamp**

Dr. Laurie Weitkamp has been a Salmon Biologist at NOAA Fisheries' Northwest Fisheries Science Center since 1992, where she works on salmon conservation,



salmon management, and salmon research. On the conservation side, she has been involved in the scientific basis for Pacific Salmon listings and recovery under the U.S. Endangered Species Act. She works on salmon management as a member of the Coho Technical Committee of the Pacific Salmon Commission, which implements the US-Canada Pacific Salmon Treaty. Her research focuses on the ecology of salmon (and recently lamprey) in estuarine and marine environments, specifically how physical conditions influence biological processes that are important for growth and survival. Since 2019, Laurie has been involved in an international effort to understand salmon ecology on the high seas in winter, a part of the salmon life cycle about which little is known. She helped plan and participate in the 2022 International Year of the Salmon Pan Pacific Winter High Seas Expedition, which involved five ships sampling 2.5 million km2 of high seas salmon habitat across the North Pacific Ocean in late winter. Laurie earned her B.S., M.S., and PhD degrees from the University of Washington.

# **Brian Erickson**

Brian Erickson is a conservation social scientist based at Oregon State University and member of the ORAFS Human Dimensions External Committee. He is a postdoctoral scholar supervised by Dr. Megan Jones in the Human Dimensions lab in the Department of Fisheries, Wildlife, and Conservation Sciences. Brian's research focuses on applying psychology and behavioral science to

conservation practice to support human wellbeing and environmental sustainability. His current projects seek to understand how to support private landowner coexistence with beavers, describe and segment fish-interested community perceptions of Oregon salmonid hatcheries, and help USGS develop training modules on the science behind successful interdisciplinary team science.

Brian's training includes a B.A. in Biology from Lewis &



Clark College, an M.S. in Teaching Secondary Science from Fordham University, an M.S. in Marine Resource Management from Oregon State University, and a Ph.D. in Fisheries (Social) Science from Oregon State University. He has a highly varied professional background with an emphasis on formal and informal education and social and ecological research.

# ORAFS is offering up to 36 opportunities for reduced registration at the 2024 Annual Meeting!

#### NEW! - Registration and Lodging for Early Career Professionals

This year we are proud to offer annual meeting registration and lodging reimbursements to up to 16 early career professionals! This reimbursement is intended to cover the cost of attendance for early career professionals that are not able to get registration and lodging covered through their employer. The reimbursement will cover both the \$300 early registration fee and up to \$325 in lodging expenses. To be considered an early career professional, you must have attended school within the last 5 years. Reimbursements will only be granted to AFS members. Those selected will be provided a code to register online and will need to provide their hotel booking confirmation for the lodging reimbursement. In the event of voluntary cancellation, reimbursements must be returned to the Chapter. Reimbursements will be granted on a first-come, first-serve basis so get your application in ASAP!

With this waiver, the Chapter offers reduced registration (\$50) to the Annual Meeting and/or a related workshop for any Tribal member or member of an Indigenous community. Professionals, students, and community members who self-identify as Tribal members or members of an Indigenous community may apply.



prepared me for a career in fisheries. From Klamath Falls to Clackamas, and Newport to Enterprise, I have gained an appreciation for all the native species that call our state home.




